205. REPORTS FROM BOROUGH & COUNTY COUNCILLORS

Borough Cllr Cannon gave the following report:

PEOPLE AND SKILLS FUND

This scheme is designed to help local people on their path towards volunteering and employment within the Tonbridge & Malling borough. Organisations can apply for grants up to £5000 towards their project. This is from a total pot of £67500 provided through an agreement with Panattoni after the development of Panattoni Park.

Each project has to achieve at least one of the following four goals:

- Enabling Special Educational Needs (SEN) students to gain experience of the workplace.
- Tackling digital exclusion to help improve quality of life and access to service.
- Helping unemployed people to access opportunities in the green retrofit sector.
- Supporting people furthest from the workplace with volunteering and enrichment activities.

While projects across the borough are welcome those focused on priority areas in the north including Ditton are particularly encouraged due to their proximity to Panattoni Park. THERMAL IMAGING CAMERA

TMBC is offering residents and community groups the chance to use a thermal imaging camera to identify areas of heat loss in their homes and buildings. PLANNING

TMBC have recently submitted their response to the new government's "proposed reforms to the National Planning Policy Framework and other changes to the planning system" consultation. The main points relevant to our parish are that TMBC

- expressed concern regarding the increased housing targets for the borough (circa 5% uplift) especially given the borough is 70% green belt.
- expressed concern how the Local Plan timetable will be affected. Some level of local control has to be maintained by achieving and supporting the Local Plan.
- stated Green belt release in the right location could be good planning for the future. [Clearly this needed to be said as we need the pressure to be taken off areas just outside the green belt such as Aylesford South & Ditton].
- expressed concern that a new call for sites will be required because of the significant increase in housing targets.
- will seek to protect the best and most versatile agricultural land in line with national policy.

 considered more transport modelling would be required when housing numbers and sites options are known.

Cllr Waters commented that the proposed houses on EMT land would be on high quality grade 2 agricultural land.

206. REPORT FROM NEIGHBOURHOOD POLICE/KCC WARDEN

PC David Warner was welcomed to the meeting. PC Warner introduced himself and advised he was now covering Ditton along with other neighbouring areas. He said he had started in his new role on 30th August and had regularly visited Ditton and had acted on information received from the parish office about possible criminal activity in the car park. He added that much of his work was traffic orientated. The Chair thanked PC Warner for attending and PC Warner said he would try to visit the area as much as he was able to.

207. COMPUTER CLUB AT YOUTH CENTRE

The Clerk advised that she had met with the KCC Warden, Chair of the Youth Centre Committee and John Marsden [volunteer trainer for computer use] at the youth centre to discuss setting up a computer to club to help people learn or problem solve. It was noted that this was first initiated by the former warden but could not be taken further until the internet/WiFi issue was resolved. This has now been done so a club could be set up. It was acknowledged that it would need to be advertised to see if there was an interest for such a club and if it would be better to offer help/problem solving or instruction on how to use computers. Members agreed to support the initiative. It was also noted that funding may need to be sought to purchase additional equipment. Cllr Waters suggested looking into the TMBC funding for digital support that the Borough Councillor mentioned in his report.

It was acknowledged that an additional junction was unlikely to be considered because this stretch is used for Operation Brock.
