It was **NOTED** that no Borough Council members were able to attend however Cllr Cannon had sent the following report regarding the recent Licensing Hearing for One Stop.

LICENSING AND APPEALS

A Licensing and Appeals Panel was convened on 23 June 2025 to consider an application to vary the premises licence to enable the applicant to supply alcohol by retail 24 hours per day following a number of objections being received during the 28-day consultation period.

Although there were 12 representations from interested parties there were either no comments or no objections received from the statutory consultees. Without representation from strategic bodies such as Police, KCC, Social Services, Environmental Health etc the Panel's hands are firmly tied and so the Licence was granted subject to a condition that between 23.00 hours and 06.00 hours alcohol can only be supplied online or through a hatch in the premises.

However if local residents experience or witness public nuisance and/or crime and disorder connected to the running of the One Stop Shop then they can raise their concerns with

- One Stop management and/or
- The Licencing Team at TMBC
- Environmental Health's Noise Nuisance Team at TMBC

If they are unable to resolve concerns by these methods then it is possible to request TMBC to formally review the licence under s.51 of the Licensing Act 2003. However detailed evidence would have to be collated to support any appeal.
